

“FENCE OF THE MONTH” CONTEST TERMS & CONDITIONS

ELIGIBILITY

“Fence of the Month” contest is open to legal residents of New Zealand, who are eighteen (18) years of age or older at the time of entry who have Internet access and a valid e-mail account prior to the beginning of the Contest Period.

Promoter has the right to verify the eligibility of each entrant.

CONTEST PERIOD

The contest begins at **January 01, 2019** and ends at **December 26, 2019**. All entries must be received on the time stated during that submission period. The period of each contest stage will be the same for every month, as below:

- Submission Period – January 01, 2019 to December 05, 2019;
- Finalists Selection Date – every 5th of each month;
- Vote Period – from 5th until 25th of each month;
- Winner Announcement Date – on or about 26th of each month.

Any changes to the competition will be notified to entrants as soon as possible by the Promoter.

HOW TO ENTER

The rules of the competition and how to enter are as follow:

- The entrants must submit a photo of a Boundaryline Product tied to a project (“Project Photo”). The photos can be submitted at any time during the Submission Period. You will find the Submission Form on the “Fence of the Month” page or you can email the Promoter on sales@boundaryline.co.nz, and send the required information. Either way, you must provide all required data to participate in the contest:

1. Client Name (Participant and/or Company);

2. Email address;
3. Product used;
4. Project Photo.

After submitting the required information on the entry form or through email, the entrant will receive one (1) email confirming the entry into the draw.

You may enter as many times as you wish.

- The entrants must be following @Boundarylinefencingsystems on Facebook in order to enter.

WINNER SELECTION

The Promoter will judge the competition and decide on a minimum of three and a maximum of five finalists by the 5th of each month. The finalists will have their photos posted in the Promoter Facebook page. The winner will be chosen as a result of popular engagement on Facebook during the Vote Period (5th – 25th of each month) measured, recorded and verified by Promoter following the below criteria:

- **Likes: 1 point** - To each "Like" that the Finalist photo receives under the Promoters Facebook page;
